3.0	Ayres Drive and Fastrack – This work is programmed in to be done asap.	HC

3.1	Castle Hill Drive traffic lightsAdam advised that HC is in the process of arranging the power supply to the toucan crossing which has been delayed due to incorrect cable size being installed within the Fastrack footpath by a subcontractor. The team is locating the best route to make the connection.	HC
3.2	Swanscombe/Whitecliffe footpathCllr Harman advised that work to clear the footpath of rubbish will not be done until the school summer holidays, when there are less people using it. Concerns regarding the signpost/crossing the road were raised. Adam has confirmed the sign is set back from the kerb and there is clear visibility. Adam, Cllr Nicklen, Cllr Harman will meet at the sign to discuss. Adam suggested that residents and councillors lobby for a Speedwatch on this section of road.	HC/PH/DN
3.3	Southfleet Road speed bumps Cllr Harman explained that since the removal of the speed bumps, the speed has been monitored and there is no difference. Cllr Nicklen advised that some residents are not happy stating it is difficult to turn onto the road. Cllr Nicklen has asked for a risk assessment. Damage caused by KCC's contractors has been reported to the Highways Officer who will ensure this is rectified.	PH/DN
3.4	Parking control in AshmereRMG confirmed they are liaising with Countryside about NPC taking over this area. Pictures were shown of bad parking. When parking control begins, vehicles parking like this will be ticketed.	RMG

3.7	<ul> <li>NCP Parking Management in Castle Hill</li> <li>RMG advised that they are looking into this to see what can be done for residents. The quarterly provision has always been there.</li> <li>Che suggested this is compared to see this is in line with Dartford's parking permit scheme.</li> <li>One of the main issues is that people who were parking in visitor bays now cannot. RMG is liaising re reducing the timing on some of these restrictions e.g a degree of parking for example overnight.</li> </ul>	RMG
